Notification

G.S.R. No. — In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Coaching-cum-Guidance Centre (Group 'C' and 'D' Recruitment Rules, 2004, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules including method of recruitment of Group 'C' posts in the Offices of National Career Service Centre for SC/STs under the Directorate General of Employment, Ministry of Labour and Employment, namely:-

1. Short title and commencement:— (1) These rules may be called the National Career Service Centre for SC/STs (Group 'C') Recruitment Rules, 2017. (2) They shall come into force on the date of their publication in the Official Gazette.
2. Application:— These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
3. Number of posts, classification, Level in Pay Matrix:- The number of posts, classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the said Schedule annexed to these rules.
4. Method of recruitment, age-limit, qualifications etc.— The method of recruitment, age-limit, qualifications etc. and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
5. Disqualifications.— No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person,shall be eligible for appointment to the said post:
Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
6. Power to relax.— Where the Central Government is of the opinion that it is necessary or expedient to do so, it may by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
7. Saving clause.-- Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-Serviceman and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
